December 18th, **2017– January 2nd**, **2018**

December 19th, 2017

Police received three separate reports of Christmas projector lights stolen from yards on 5th & 6th Street overnight.

Anyone with information regarding these incidents is asked to call the Morden Police Service at 822-4900, Crime Stoppers at 1-800-222-8477, submit a secure tip online at www.manitobacrimestoppers.com or text "TIPMAN" plus your message to CRIMES (274637).

December 20th, 2017

Around 11:45 pm, police received a 911 call of a motor vehicle accident on Rampton Street involving a vehicle colliding with a tree. The driver informed police he was travelling east bound on Rampton Street around a curve when an on-coming vehicle was taking the same corner and appeared to be in his lane. The driver tried evading the other vehicle, panicked, and pulled the emergency brake causing the vehicle to spin and lose control, sliding over the curb and into a tree. There were no injuries as a result of the accident.

December 22nd, 2017

Police received a call of a domestic dispute at a residence in Morden. Police attended to find that the caller's ex-husband was refusing to leave the residence after finishing a visit with their children. The parties had a disagreement but there was no report of any assault or threats. Police remained on scene to ensure the situation did not escalate and the husband departed the residence. There were no charges as a result of this incident.

December 23rd, 2017

Police were dispatched to a motor vehicle accident around 2:35 pm at the corner of Thornhill Street and Mountain Street. A vehicle was travelling west bound on Thornhill Street and conducting a northbound turn onto Mountain Street. A second vehicle travelling east bound on Thornhill Street entered the intersection when the first vehicle executed the turn, causing the accident. There were no injuries as a result of the accident but both vehicles required towing.

December 24th, 2017

Police received a 911 call around 5:00 pm to a motor vehicle accident on 19th Street in Morden. Police arrived on scene to find a single vehicle up on the boulevard that struck a tree. The driver of the vehicle could not remember what happened and was transported to Boundary Trails Health Centre for further evaluation.

December 28th, 2017

Police were dispatched to an apartment complex on Mountain Street at 5:30 pm regarding a male banging on a door. The caller advised that the male was currently sitting on the steps yelling. Police arrived on scene but the suspect was gone. Police spoke with an occupant of one of the apartments who provided a name of the suspect and advised he was intoxicated. Police were unable to find the suspect at this time but later received another call around 10:00 pm that the male was back at the apartments. Police attended and found the male in the parking lot of Rock's Bar & Grill. He was intoxicated but cooperative and was transported home without charges.

December 29th, 2017

Police received a dispatch around 12:00 pm to assist paramedics at a residence on Mountain Street in Morden. Police attended to the residence which was found to be in disorder with blood on the floors and walls. There was a male, known to police, on the phone with ambulance dispatch and a victim was located in a bedroom with blood and injuries to his face. The victim could barely communicate with police due to his injuries but was able to get out some words indicating a fight last night with the suspect who was on the phone. Paramedics attended to the victim and transported him to Boundary Trails Health Centre for medical attention. The suspect was placed under arrest for Assault Causing Bodily Harm, transported to the Morden Police Service and lodged in cells. Police spoke with some witnesses who advised that they saw the suspect attend the victim's residence the previous night between 9:00 and 10:00 pm with a bottle of liquor and go inside. Later this day, police attended to the hospital to speak with the victim again and he was able to provide some further details. The victim advised that the suspect in custody came to his residence around 11:00 pm the previous night and they started drinking. They got into a disagreement and the suspect attacked him with a knife and assaulted him several times. As a result, 40 year old Jeffery Robert Funk of Morden is charged with Assault with a Weapon and Assault Causing Bodily Harm. He was remanded into custody and transported to the Winnipeg Remand Centre where he awaits his next court appearance January 2nd in Portage la Prairie.

January 1st, 2018

Around 5:45 am, police received a call of an intoxicated male banging on a garage door. While attending, police received more calls of this individual causing a disturbance in a back yard on Mountain Street. The male attempted to enter a

residence and damaged a screen door. He was last seen going towards the creek area. Police located the male at the bottom of the creek yelling. Police assisted the individual out of the creek and placed him under arrest under the Intoxicated Persons Detention Act. He was lodged in cells until sober and released later in the day without charges.

December 11th - December 18th, 2017

December 12th, 2017

Police were on patrol at 1:50 pm when they observed a disturbance between a pedestrian and a driver. A pedestrian was crossing Stephen Street at the intersection of 7th Street. A vehicle was turning from 7th Street onto Stephen Street and failed to see the pedestrian crossing. The vehicle came in contact with the pedestrian at which time he became angry and started hitting the vehicle with his hands. Police mediated the situation and ensured there were no injuries. There were no charges as a result of this incident.

December 12th, 2017

A 33-year-old male from Morden has been charged with Assault and two counts of Fail to Comply with a Probation Order after a lengthy investigation. The accused and the victim were in a common law relationship. The accused had previously assaulted the victim resulting in a two year Probation Order with conditions not to have any contact or communication with the victim and the to keep the peace and be of good behavior. Police were dispatched to an address on November 19th around 7:30 am regarding a suspicious incident. It was learned that the accused had assaulted the victim several times throughout the evening. Both the accused and the victim had been drinking. Due to previous charges, the accused was remanded into custody and will be appearing in Morden Provincial Court in January.

December 12th, 2017

Police were called to an apartment complex around 3:45 pm where a male was observed sitting in his vehicle in the parking lot. The caller advised that the person in the vehicle was an ex-boyfriend and felt he was sitting there to watch what she was doing. Police attended and spoke with the male who appeared to be under the influence of a substance. The person tried telling police he was waiting for a friend but when confronted of the real reason he was there, he did not deny it. The 49-year-old male was given a ride home and issued a warning for criminal harassment.

December 14th, 2017

Police have a second Warrant for Arrest for 28 year old Alexey EYKHORST of Morden. Last week, police reported Eykhorst was wanted for two counts of breaching conditions of his Recognizance. Eykhorst was placed on a Recognizance by the courts with one of the conditions being to abide by a curfew of 10:00 pm to 7:00 am. Further to this, Eykhorst was also charged with two counts of Fail to Comply with a Recognizance and was to appear in Morden Provincial Court December 12th as well as report to Morden Police Service for identification purposes. Eykhorst failed to attend court and failed to report for identification purposes. As a result, another Warrant for Arrest was issued by the courts. December 4th, 2017

Police received a report of a hit and run to a vehicle that occurred on December 4th at the intersection of 1st Street and Thornhill Street in Morden. The driver was facing west stopped in the intersection to allow traffic to pass before executing a left turn. A vehicle travelling from behind failed to see that they had stopped and ran into the back end of the stopped vehicle. The driver of the second vehicle got out, asked if the driver was injured and said there was no damage. The first vehicle pulled off to the side to allow traffic to pass and expected the other involved vehicle to pull over as well to exchange particulars, but it drove off. The suspect vehicle is described as a black SUV. The victim in this incident was driving a 1998 red Dodge Neon. December 7th, 2017

Police have a Warrant for Arrest for 28-year-old Alex EYKHORST for two counts of breaching conditions of his Recognizance. Eykhorst was placed on a Recognizance by the courts with one of the conditions being to abide by a curfew of 10:00 pm to 7:00 am. On December 7th around 12:01 am, police attended to conduct a curfew check on Eykhorst but he was not home. As well on December 8th, police attended to conduct another curfew check around 1:00 am and found that he was not home. Eykhorst is currently before the courts on two previous charges of Breach of Recognizance for not following his curfew as well as a charge of Break, Enter and Commit Assault from Lundar, Manitoba in October 2017. December 9th, 2017

Police were called to Traveller's Inn in Morden around 3:00 pm for a complaint of eight people fighting in front of the establishment. Police arrived to find the fight was over and the suspect departed. The male suspect was fighting with two other male patrons inside the establishment when staff asked them to leave. An employee received a minor injury during altercation but declined medical attention and declined pursuing charges. The recommendation was to ban the suspect from being able attend back to the business.

December 9th, 2017

Around 10:00 pm, police received a complaint about a vehicle with a driver that was possibly impaired travelling west into Morden. Police observed the vehicle travelling west bound and turn onto 3rd Street in Morden heading north at a very slow rate of speed. Police activated emergency light and the vehicle stopped for a few seconds and then started moving again. It eventually came to a complete stop at which time a female passenger exited the vehicle, dropped a beer can on the ground, and ran towards police. She was arrested and turned over to the Winkler Police Service on an unrelated matter. Police approached the vehicle and spoke with the male driver who had an odor of liquor on his breath and glassy eyes. Police also observed an open can of beer in the pocket of the driver's door and one in the centre console. The driver was arrested for impaired driving and placed in the police vehicle. A breath demand was made and the driver provided two samples of his breath resulting in two readings of 150mg%, also twice the legal limit. As a result, the 51-year-old male driver from Winkler is charged with Driving Impaired and Driving over .08. He has two previous convictions for driving impaired and will be appearing in Morden Provincial Court in January.

November 27th – December 4th, 2017

November 27th, 2017

While investigating an unrelated incident, police attended a residence in Morden and discovered a male inside that had a Warrant out for his arrest by Morden Police Service for 7 counts of Unauthorized Use of a Credit Card and 2 counts from Winnipeg. The 28-year-old male from Winnipeg also had two Warrants for Arrest held by the Winnipeg Police Service for Fraudulently Personate Another Person to Avoid Arrest and Fail to Comply with Conditions of a Recognizance. A second 55-year-old male from Morden inside the residence, was on an order to have no contact with the first male. He is charged with Breach of Undertaking

and both individuals were arrested and released on Promises to Appear in Morden Provincial Court in January 2018. The male with Warrants from Winnipeg was released on a Winnipeg Provincial Court date in January as well.

November 28th, 2017

Police received a call from Probation Services of an individual at their office who had a Warrant out for their arrest. Police attended and arrested a 17-year-old female from Winkler for Failing to Comply with a Probation Order by not reporting to Probations by a specified date. The individual was released on a Promise to Appear in Morden Provincial Court in January.

November 28th, 2017

Around 5:30 pm, police were dispatched along with Fire and Paramedics to a two-vehicle accident at the intersection of 1st Street and Thornhill Street in Morden. Police attended and observed two vehicles with extensive damage. The driver of one of the vehicles was still in the driver's seat, not hurt, but was disoriented and spoke in a slow deliberate manner with mumbled speech. Upon speaking more with the driver, there was no odor of liquor but it was determined that he was under the influence of an intoxicating substance. The driver was asked to exit the vehicle at which time an odor of marihuana was detected coming from inside. The driver was unsteady on his feet and needed to hold on to the vehicle to steady himself and maintain balance. Paramedics cleared the driver at the scene for any injuries. Police attempted to administer a Standard Field Sobriety Test roadside at which time the driver became uncooperative, swearing at police. He eventually completed the tests, but failed. The driver was arrested for Impaired Operation of a Motor Vehicle by Drug. While attempting to place handcuffs on the accused, he began to resist and became combative with police by pulling his hands away. The accused was eventually handcuffed and transported back to the Morden Police Service. While searching the driver, a quantity of shatter (marihuana derivative) was discovered in his jacket. Police called in their Drug Recognition Expert to administer more testing with the driver, but he refused to cooperate and comply with the demands made. As a result, the 17-year-old driver was charged with Impaired Operation of a Motor Vehicle by Drug, Refuse Drug Recognition Expert Demand, two counts of Possession of a Controlled Substance and Disobey Traffic Control Device – Red Light. He will be appearing in Morden Provincial Court in January.

November 28th, 2017

Police were called to a local business in Morden around 6:30 pm regarding a male that was in the bathroom using drugs. The suspect had since left the business with no shoes. Police attended the area and received a second dispatch of the male now outside a different business in Morden. The male was heavily intoxicated by a drug, very unsteady on his feet and had slurred speech. Police

arrested the individual under the Intoxicated Persons Detention Act. The 20-year-old male was lodged in cells and released when sober without charges.

December 1st, 2017

Received a call at 9:40 am from an off duty officer who was at Home Hardware in Morden and observed a male and female together, known to be on an order not to have any contact or communication with each other. Police attended and arrested both individuals. The female had two Warrants for Arrest for Fail to Attend Court and for Fail to Comply with Recognizance Conditions as well as being on conditions not to have any contact or communication with the male suspect in this case. The male had been released by the courts on a Recognizance with conditions to have no contact or communication with the female and is on a Probation Order to have no contact or communication with the same female. The 30-year-old male and the 31-year-old female were both remanded into custody and transported to Winnipeg. They both remain in custody awaiting their next court appearance.

December 1st, 2017

Police were on general patrol when they observed a vehicle in the Shoppers Drug Mart parking lot with no front license plate. A check with police dispatch indicated the vehicle registration was inactive. Several minutes later, the vehicle moved and was observed travelling west on North Railway Street. The vehicle was stopped and the male driver advised that the vehicle was not registered and he did not have a driver's license. Police spoke with the female passenger who had a purse on her lap that appeared to be very full. The female passenger in the vehicle was recognized as the suspect from a previous theft at Shoppers Drug Mart in Morden. Police observed some items in the back seat that the passenger was trying to conceal. When questioned, the driver and passenger were giving inconsistent answers for explanations as to why they were in Morden and where they had been. The female produced receipts for very small purchases in Winkler, but were inconsistent with the products seen within the vehicle. Police determined that the couple was staying in Winkler and a large inventory of items. also believed to be stolen, was located inside a hotel room. All items were seized and police are continuing their investigation.

November 13th - November 27th, 2017

November 13th, 2017

Police were dispatched to a motor vehicle accident at Loren Drive and La Verendrye Boulevard around 3:00pm. An eastbound vehicle was stopped at the stop sign on Loren Drive when a second vehicle failed to see the vehicle stopped and ran into the back end of the first vehicle. The occupants of the first vehicle

were transported to Boundary Trails Health Centre for observation complaining of sore necks. Both vehicles required towing from the scene.

November 15th, 2017

Sometime overnight, a vehicle was damaged while parked on 11th Street in Morden. The owner parked his 2008 red Honda Civic in the 100 block of 11th Street and returned in the morning to find someone had keyed the rear door on the driver's side. November 17th, 2017

Around 11:30 pm, police received a dispatch call to Tim Horton's in Morden reporting an intoxicated male. Police attended and found a male sleeping in one of the booths. As police were trying to speak to the individual, he stood up and said he would walk home. Police tried to take hold of the individual at which time he slapped the officer's hand and swore. Police took hold of the male and arrested him under the Intoxicated Persons Detention Act. While trying to handcuff the individual, he pulled his hand back and began to resist. The individual was placed on the ground and handcuffed. He was lodged in cells overnight until sober and released in the morning without charges.

November 19th, 2017

Police were on general patrol around 1:25 am travelling east on Thornhill Street when they observed a vehicle travelling in front of them veering back and forth in its lane. Police activated emergency lights and stopped the vehicle. While speaking with the driver, police observed an odor of liquor on his breath and requested he provide a sample of his breath on a roadside screening device. The test resulted in a fail and the driver was arrested for impaired driving. Subsequent breath samples were obtained and analyzed at 120 and 110 mg%. As a result, the 20-year-old Morden driver was charged with Driving Impaired and Driving over .08. His vehicle was impounded for 30 days and he will be appearing in Morden Provincial Court in January 2018.

November 19th, **2017**

Police were called around 7:30 pm where an intoxicated male entered a residence uninvited and then left shortly after. Police attended and located a male outside of the residence that had been drinking. After speaking with him, police were satisfied that there was no intent by the individual and he was returned to his residence without charges.

November 20th, 2017

A vehicle was vandalized while parked in Rock's Bar & Grill parking lot on November 18th. The incident occurred sometime between midnight and 2:00 am. The owner of a 1990 black Mercedes Benz advised that the front hood emblem had been broken off. November 25th, 2017

While conducting a Manitoba Public Insurance checkstop, police had opportunity to speak with a driver who had an odor of marihuana on her breath and glossy eyes. The driver advised she had not consumed any alcohol but she had smoked half a joint ten minutes before being stopped by police. A clear plastic bag of marihuana was observed inside the vehicle along with numerous paraphernalia items. Police conducted a Standard Field Sobriety Test with the driver who passed. All items were seized for destruction and there were no charges as a result of this incident.

November 26th, 2017

Police were stationary on Thornhill Street conducting a Manitoba Public Insurance checkstop when a vehicle was observed to make a quick wide turn onto Thornhill Street and continued travelling westbound. Police pursued the vehicle and observed it to make quick movements in its lane and back. The vehicle was stopped and the driver advised of what police observed. The passenger indicated he had grabbed the steering wheel and admitted to consuming liquor. The driver was observed to have a strong odor of liquor on her breath, glassy eyes, slurred speech and was argumentative with police. The driver was asked how much she had to drink and she indicated "nothing". When asked to exit the vehicle, the driver had slow deliberate movements. She was arrested for impaired driving and a demand was made to provide samples of her breath. Two breath samples were obtained resulting in readings of 180 and 160 mg%, double the legal limit. The 28-year-old female driver from Winkler was charged with Drive Impaired and Drive over .08. Her vehicle was impounded for 60 days and she will be appearing in Morden Provincial Court in January 2018.

November 6th - November 13th, 2017

November 8th, 2017

While on general patrol, members of the Morden Police Service observed a vehicle travel towards their location suddenly stop and pull over to the curb. Police knew the identity of the driver who was known to be a suspended driver. As the vehicle passed police, the driver attempted to cover his face. Police

conducted a traffic stop and further checks confirmed the driver of the vehicle was a Suspended driver. As a result of the traffic stop, a 30-year-old male resident of Morden has been charged with driving while disqualified. The accused vehicle was impounded for a mandatory minimum of 30 days.

November 10th, 2017

Police received a Warrant of Arrest on behalf of Manitoba Probation Services for an individual who failed to comply with his conditions and was believed to reside in Morden. Members of the Morden Police Service located the individual and placed him under arrest on the strength of the warrant. As a result, the 30-year-old resident of Morden was released on a Promise to Appear in Morden Provincial Court in December.

November 10th, 2017

Police received a report of a hit and run to a vehicle that occurred on November 9th at the Rock's Bar parking lot. The driver returned to his vehicle, a 2004 red Pontiac Grand AM, and observed damage to the rear bumper area. November 12th, 2017

On this date at 2:50 am, police were on patrol and observed a vehicle travelling in front of them with no taillights. Police conducted a traffic stop and while speaking with the driver observed an odor of liquor coming from the vehicle as well as open alcohol containers inside the vehicle. The driver was subsequently placed on a roadside screening device which resulted in a fail. The driver was subsequently arrested for Driving over the legal limit of .08. The accused was transported to the Morden Police Service and provided breath samples of 130 mg% and 120 mg%. As a result, a 28-year-old Winkler resident has been charged with Impaired Driving, Driving over the legal limit of .08 and Unlawful Tansportation of liquor in a motor vehicle. The vehicle was seized for a mandatory 30 day vehicle impoundment. The accused was released to appear in Morden Provincial Court in December.

November 12th, 2017

On this date at 4:15 pm, members of the Morden Police Service were conducting Traffic Enforcement and stopped a vehicle with multiple occupants. Upon speaking with the driver, police observed the front seat passenger to be smoking a cigarette, while there were two youths in the rear seats of the vehicle. As a result, a 17-year-old female resident of Morden was issued a Provincial Offence Notice under the Highway Traffic Act for - Smoke or have lighted tobacco in a motor

vehicle while another person who is younger than 16 years is in it. This ticket carries a fine amount of \$203.80.

October 30th – November 6th, 2017

November 1st, 2017

Police have a Warrant for Arrest for Anna Unrau of Morden. Unrau is wanted for Possession for the Purpose of Trafficking, two counts of Breach of Undertaking, two counts of Possession of Property obtained by Crime, two counts of Forgery, two counts of Uttering Forged Documents and one count of Assault with a Weapon. She was released on a Promise to Appear at Morden Provincial Court on September 12th. These matters were remanded to October 31st but the accused failed to show, resulting in a Warrant being issued. November 3rd, 2017

Around 7:30 pm, police were checking license plate numbers when a vehicle came up as unregistered. Police stopped the vehicle and upon speaking with the driver, observed a small silver pipe in the centre console. The driver handed over a silver metal pipe with marihuana residue as well as a quantity of marihuana. The 35-year-old male from Morden was issued a Provincial Offence Notice for Drive Unregistered Vehicle and a warning for Possession of a Controlled Substance.

November 4th, 2017

Police were dispatched to an apartment at 6:10 pm where someone was yelling and crying for the past hour. Police located a male in an apartment who was intoxicated and advised that he was in fact upset and was yelling. Police searched the apartment for other individuals but no one was there. A warning was issued for causing a disturbance. Police were later called back to the same apartment complex an hour later to deal with the same individual. The male was now in the hallway intoxicated and had fallen down some stairs but was not hurt. The 33-year-old male was arrested under the Intoxicated Persons Detention Act and lodged in cells until sober. There were no charges as a result of this incident. The next morning around 6:35 am, police received a third call of the same male yelling in his apartment. Police attended and spoke with the same individual once again who agreed to go to sleep. Charges are pending.

November 4th, 2017

Police were dispatched to a motor vehicle accident around 8:30 pm at the corner of 2nd Street and Wardrop Street in Morden. A vehicle travelling south on 2nd Street failed to stop at the stop sign due to icy road conditions and struck a vehicle travelling eastbound on Wardrop Street. The vehicle that slid through the intersection was a novice driver and required a supervising driver, which they did not have. There were no injuries as a result of the accident. The 16-year-old driver was issued a Provincial Offence Notice for Operate a Motor Vehicle in a Stage without a Supervising Driver.

October 23rd, 2017

Police received a report of a vehicle that was vandalized while parked on North Railway Street in Morden. The owner parked her vehicle across from the Traveller's Inn around 10:30 pm on October 21st and picked it up at 9:00 am the next morning. When the owner picked up the vehicle, she noticed that someone had scratched the back bumper with an object. The vehicle that was damaged is a 2013 silver Ford Focus. October 26th, 2017

A 27-year-old male from Morden has been charged with 2 counts of Breach of Recognizance after police conducted a curfew check. The accused was place on a Recognizance on October 10th with one of the conditions to be at his home address between 10:00 pm and 7:00 am. Police attended to his residence but his mother advised that he was not home and did not know where he was. Around 9:00 pm, police were conducting a checkstop and while speaking with a driver of a vehicle, officers immediately detected an odor of marihuana coming from inside. The driver admitted to just recently smoking a joint with his girlfriend and that there was a roach in the ashtray of the car. A check with police dispatch indicated the driver's license was expired and he was on an Undertaking with conditions not to possess or consume any intoxicating substances. The driver was arrested and a subsequent search of the vehicle found the marihuana cigarette and a metal grinder. Members of the Morden Police Service received a 911 call to a family dispute at a residence in Morden. Police responded to the residence and learned that two family members had got into an argument. One of the involved parties had already left prior to police arrival. Police spoke with the remaining family members and the situation had calmed down. No charges were laid as a result of this incident.

The cell phone also had the owners credit card, debit card and cash with it. On this date at around 2:30 in the morning, police conducted a traffic stop on a vehicle for multiple violations. Police spoke with the driver and conducted checks of her drivers licence. Police learned that the driver was Suspended and the 26

During this reporting period, police issued 15 Provincial Offence Notices to drivers. Out of those charged, **8** were for drivers caught using their cell phones while driving. Police remind the public that over and above the usual safety concerns, this ticket carries a penalty of \$203.80 and points against their licence.

May 1st - May 8th, 2017

May 1st, 2017

Members of the Morden Police Service received several 911 calls, to a disturbance at a residence, and one call from neighbors reporting screaming. Police arrived on scene and were met by one of the parties advising police that the female suspect had thrown a bottle at her one year old causing the child to cry. As police approached the residence, the suspect threw an object at police and slammed the door on officers. Police entered the residence to arrest the suspect and she continued to resist the arrest. While officers were dealing with the suspect, a male occupant became aggressive with officers and a conducted energy weapon was used to gain his compliance. DYCK had been released on his own Recognizance on prior charges and failed to comply with the conditions of his release. April 24th - May 1st, 2017

April 24th, 2017

Police received a report from a property owner that a disturbance had occurred at one of their properties the previous evening and asked police to assist with checking on the residence. Police learned that the tenant/victim had returned home in the early morning hours and found his ex girlfriend causing damage to the residence. Upon entering the residence, the victim was assaulted by the accused, causing minor injuries to his facial area. The victim was alerted to this being a scam before any money had been transferred but may have allowed the culprit(s) access to their computer.

April 26th, 2017

In the early morning hours, members of the Morden Police Service conducted a traffic stop on a suspected Suspended Driver. While attempting to stop the vehicle, police observed the driver and front passenger to switch seats. Police approached the vehicle and observed two young children inside the vehicle. He was apprehended but the 18-year-old male denied throwing any beer bottles. Police spoke with other individuals in the group who also denied any involvement. The investigation is continuing.

March 25th, 2017

While on general patrol around 2:00 am, police observed a vehicle on Mountain Street in Morden pull over to the curb to allow some pedestrians to get in. He will be appearing in Morden Provincial Court in May.

February 28th, 2017

At approximately 3:00 am, members of the Morden Police Service arrested a 20-year-old Winkler man for breaching the conditions of his undertaking. The arrest was the result of the accused contacting the victim contrary to the conditions of his release. Other Police Activities (alarms, criminal record checks, assist other agencies, Lost / Found Property, K9 assistance, mental health act, 24 hour suspension) – 26

December 19th, 2016

Police received a report from the victim, that on the previous day, his vehicle was damaged by an individual that was known to him. The victim explained that he was travelling in his vehicle and observed the suspect to be upset and yelling at him over a past incident. The victim continued to drive away but was followed by the suspect, who continued to yell and swear at him, and he began punching the driver side of his vehicle. The victim again drove away but was followed to the next intersection, where the suspect continued to yell and swear at him, and began punching the passenger side of his vehicle. Police observed numerous dents on both sides of the victim's vehicle. Police obtained a formal statement from the victim and charges are pending against the suspect.

Police received a call from a resident reporting that he believed an assault had occurred inside his residence. Police attended to the residence and spoke with

two parties that had been involved in a dispute. The two suspects were known to each other and confirmed that an argument escalated to the point of pushing and shoving, with one of the parties being struck. Both parties were cooperative with police and did not want charges laid in this incident.

The 53 year old male was charged with Breaching a Protection Order and 2 counts of Breaching his Probation Order. The accused was remanded into custody and transported to the Winnipeg Remand Centre to await his next court appearance.

Police received a report of a Theft that occurred sometime between 12 noon and 12:30 pm from their business located in the 300 block of Stephen Street. The victim advised police that they had heard someone enter the business, between those times, but did not notice anything missing until a short time later. The victim is now missing a brown brief case described as having a top flap with a shoulder strap, and a black Ipad mini. Police received a description of a person of interest who was in the area at the time. Police are wishing to speak with this person described as a short female, approximately 40 years of age and who was wearing a white jacket. Police continue to investigate this matter.

Police received a call from a female victim reporting that she been assaulted by a male suspect. The victim reported that she had gone to sleep with her boyfriend and awoke to male acquaintance who was touching her in a sexual manner. A 49 year old resident of Winkler has been charged with Sexual Assault and breaching the conditions of his Undertaking. The accused was released on more conditions and will be appearing in Morden Provincial Court in February.

Police attended to the victims' residence and located extensive damage to a rear door that opens into the attached garage portion of the residence. The suspect(s) are believed to have pryed at this door but were unable to gain entry into the residence. The homeowners had left their house the evening prior and returned on this date to see the damage.
